Sub: Result of Screening Process for filling up one post of Chief Engineer at CSIR Hqrs., New Delhi – reg.

Ref.: Advertisement No. R&A/03/2025.

Attention of all the candidates is invited, who had applied for the post of Chief Engineer against CSIR Advertisement No. R&A/03/2025.

2. As per the stipulations of the advertisement, the eligible candidates were required to submit online applications through CSIR official website by 19.09.2025. The candidature of only those applicants whose online application were received within the stipulated time [including fee payment if applicable], before the last date for submission of online application has been considered.

3. Duly constituted Screening Committee has considered all the 35 applications and decided the following criteria for Shortlisting the candidates for appearing in the interview for final selection:

(i) Essential Educational Qualification as per Advertisement with minimum **20 years' of relevant experience** as a **regular employee** in **Central Government/State Government/Autonomous Body**;

OR

(ii) Essential Educational Qualification as per Advertisement with minimum **20 years' of relevant experience** as a **regular employee** in PSUs;

OR

(iii) Essential Educational Qualification as per Advertisement with minimum **24 years' relevant experience** of working in **Private Sector including Central Government/State Government/Autonomous Body/PSUs** etc.

4. Based on the recommendations of the Screening Committee, the list of the candidates provisionally shortlisted to appear for Interview and the list of candidates not recommended by the Screening Committee for further consideration along with the reasons mentioned thereon against each name are listed in Annexure-I & Annexure-II respectively.

5. The screening of the applications of candidates has been done prima facie based on information furnished in the online application and the supporting documents uploaded by the candidates.

6. While every care has been taken in preparing the results of screening process, however, CSIR reserves the right to rectify inadvertent error or typographical/printing mistakes, if any, at any stage.

7. Representations, if any, of the candidates, can be submitted through e-mail at ra.helpdesk@csir.res.in mentioning application number, name etc. and duly enclosing proof in support

of his/her claim existing as on last date of receipt of online application, during the period from 03.12.2025 to 10.12.2025 (till 17:00 hours). The representation(s) received after stipulated period will not be entertained. Representation(s) submitted by other means will not be entertained.

8. The decision of the Competent Authority, CSIR on such representations will be final and binding in this regard.

9. The date of interview and documents verification for selection to one post of Chief Engineer in CSIR HQ will be intimated separately. Candidates are advised to visit the CSIR website on regular basis for further communication. Intimation to shortlisted candidates for appearing in document verification cum interview will be issued separately.
