Sub: Result of Screening Process for Recruitment to the 08 posts of Section Officer in CSIR from the list of non-recommended candidates of UPSC's Civil Services Examination 2024-reg.

Attention of all the candidates is invited who have applied for the post of Section Officer against CSIR Advertisement No. E-I/RC/2026/1.

2. As per the provisions of the advertisement, candidates were required to submit online applications through CSIR Official website by 04.02.2026. The candidature of only those applicants whose online application were received within the stipulated time (including online fee payment, if applicable), have been considered.

3. Shortlisting criteria: A total of 500 applications [UR:185, SC:58, ST:11 and OBC:182, EWS:64] received against the aforesaid advertisement, were considered by a duly constituted Screening Committee.

4. In accordance with the provisions contained in para 6 of the advertisement, the applications have been shortlisted on the basis of total marks (i.e. Mains plus Personality Test) obtained by the candidates in UPSC's CSE-2024. The count of shortlisted candidates is calculated in the ratio of 1:2.5 against the number of posts for each category, subject to minimum 03 candidates. In case tie of total marks of last candidate, all the candidates who obtained similar marks, have been considered to be called for Interview.

5. Following category-wise cut-off marks in UPSC's CSE-2024 has been fixed for shortlisting of candidates for appearing in interview for the post of Section Officers: -

7. The shortlisting of the applications of candidates has been done prima facie based on information furnished and the supporting documents uploaded by the candidates in their online applications.

8. While every care has been taken in preparing the results of the shortlisting process, however, CSIR reserves the right to rectify inadvertent error or typographical/printing mistakes, if any, at any stage.

Representations against the shortlisting, if any, can be submitted through e-mail at ra.helpdesk@csir.res.in mentioning application number, name etc. and duly enclosing proof in support of his/her claim existing as on last date of receipt of online application, within 05 days of publication of this notice, i.e. latest by 24.02.2026 (till 17:00 hrs). The representation(s) received after stipulated period and/or submitted through other means, will not be entertained.

10. The decision of the Competent Authority, CSIR on such representations will be final and binding in this regard.

11. The Interview-cum-Documents Verification is scheduled to be held on 14.03.2026 (Saturday) in Delhi. Candidates are advised to visit the CSIR website and check their registered e-mails regularly for further communication in this regard.
