Sub.: Clarification in cases where appointment offers were issued before 05 years vacancy age and the candidate joins after 05 years vacancy age – reg.


The undersigned is directed to state that this office has received references seeking following clarification on the subject matter. These issues have been examined in consultation with IFD, CSIR. Accordingly, the following is clarified:

S. No.	Point of Doubt	Clarification
1	Whether revival is required, in cases where offer of appointment has been issued in July, 2025 but after 5 years i.e after 16.07.2020 or 5 years of arising of vacancy, whichever is later, in light of CSIR clarification issued vide letter No. 5-1(14)/2008-PD dated 06.07.2024 in respective of Administrative Posts.	In cases where offer of appointment has been issued in July, 2025 but after 5 years i.e after 16.07.2020 or 5 years of arising of vacancy, whichever is later, may require revival in terms of DOE OM dated 04.01.2024.
2	If offer of appointment has been issued within 5 years of arising of vacancy, and <u>the selected candidate joins the post but resigns the post within one year of his joining</u> , however, the date of arising of original vacancy of the said post have past 5 years, whether in such cases appointment offer from reserve list may be issued in terms of DoPT OM dated 13.06.2000.	Yes, within the validity period of the panel, the reserve/waiting panel may be operated with the approval of Appointing Authority subject to fulfilling the the conditions stipulated in DoPT OM dated 13.06.2000 and the vacancy may be filled from among the candidates available in the waiting list, strictly in order of merit and within the same category against which the vacancy has arisen.

2. The above may be brought to the notice of all concerned for information, guidance and compliance.
