The CSIR-Traditional Knowledge Digital Library (CSIR-TKDL) Unit is a constituent of Council of Scientific and Industrial Research (CSIR), an autonomous body with the Department of Scientific & Industrial Research (Ministry of Science and Technology). The CSIR-TKDL Unit is engaged in protection and preservation of India's vast traditional knowledge present in ancient texts by digitizing the information into modern languages in structured format. The key objective is averting the misappropriation of Indian traditional knowledge through the wrong acquisition of intellectual property rights.

CSIR-TKDL Unit invites eligible Indian Citizens who meet the necessary educational and work associated requirements for walk-in-interview for engagement as project manpower under the project, "***The Importance of Traditional Wisdom: Environmental Consciousness in Vedic and other literature and its Relevance for Modern Climate Strategies (GAP-000001)***" being implemented at the Unit. The engagement is purely temporary, time-bound and on contract basis. The engagement is maximum up to 15<sup>th</sup> January 2027 and co-terminus with the project duration. **Desirable Qualification:** Experience in handling environmental monitoring /climate change related project activities will be preferred.

**Post Code TKEE02: Senior-PAT (Environmental Engineering/ Energy)**

**Essential Qualification:** Bachelor's Degree in Engineering/Technology in Environmental Engineering /Environmental Management or related disciplines from a recognized University or equivalent and minimum 03 years' experience in Research & Development in Industrial and Academic Institutions or Science & Technology Organizations and scientific activities and services

**Desirable Qualification:** Good knowledge of programming related to machine learning (ML). Working experience with Python and ML (libraries such as pytorch, tensorflow, etc.).

**Job Description:** To analyse and process data generated under the project for preparation of reports, presentations, documentation, research articles, besides any other project work assigned.

**Post Code TKEE06: PAT-I (Sanskrit)**

Essential Qualification: Master's / Integrated Master's Degree in Sanskrit language from recognized University or equivalent.

**Desirable Qualification:** Experience in translation of Sanskrit texts will be preferred.

**Job Description:** Identification of traditional wisdom from select Vedic texts and other literature and establishing contextual interpretation of identified information on subject matter.

**General Instructions:**

1. The Project Associate position(s) is on a contract basis and will be up to 15<sup>th</sup> January 2027 only or co – terminus with the Project duration. However, in any case, under no circumstances the tenure of project personnel(s) who have worked with CSIR-TKDL Unit or any other laboratories /Institutes of the CSIR under one project or combination of different projects would be allowed to exceed beyond six-year duration.
2. Candidates are required to report for interview with duly filled application in prescribed format (copy attached), and bring all certificates in original and, a set of self-attested photocopies of the same, in support of age, qualification and experience for verification. Incomplete application in any form will be rejected.
3. The Upper age limit shall be calculated as on the date of the interview.
4. Only those candidates who have acquired the essential qualification & result has been declared (should have at least a provisional certificate) are eligible to appear in the walk-in-interview.
5. Result awaited /final semester appeared candidates are not eligible to appear in the walk-in-interview for the position where such minimum essential qualification requirement is mandatory.
6. Experience, where required, will be counted from the date after acquiring the essential minimum educational qualification. Dissertation/thesis work conducted during the academic period will not be counted as experience.
7. The period of experience rendered by a candidate Part - time, daily wages, visiting/ guest faculty etc. will not be counted while calculating the valid experience for short listing the candidates for interview.
8. Time spent in acquiring minimum higher qualification will not be counted as an experience over essential qualification.
9. Mere fulfilling of minimum qualification does not confer any right to a candidate for selection.
10. No upgradation of the project staff shall be done in the same or any new project.

17. If currently employed, then the candidate will have to furnish No-Objection Certificate from the current employer at the time of interview.

**Note:**

1. Candidature will be purely provisional subject to fulfilling the eligibility criteria.
2. No TA/DA will be paid for attending the Interview.
3. Tenure of engagement of the Project Staff shall be co-terminus with the project. In any case, under no circumstances the tenure (inclusive of all CSIR postings) would be allowed to exceed six years duration. The performance of the Project Staff would be reviewed periodically so that one not found up to the mark, could be terminated without assigning any reason.
4. The engagement of Project Staff is purely on contract basis in respect of the above positions therefore will confer no rights on the candidates, whatsoever, implicitly and/or explicitly for their continuation beyond tenure/absorption /regularization in CSIR. Contract may be terminated at any time at a notice of one month from either side or one-month stipend in lieu thereof.

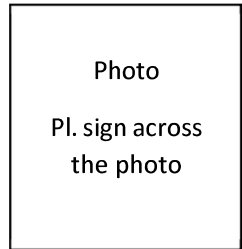
