


Sir/Madam,

I am directed to state that the provisions of Model Code of Conduct are enforced from the date of announcement of election schedule by the Election Commission and remain in operation till the completion of election process.

2. Now, that the results in respect of General Election to the Legislative Assemblies of **Assam, Kerala, Tamil Nadu, West Bengal and UT of Puducherry, 2026** and Bye-elections in Assembly Constituencies of Gujarat, Karnataka, Maharashtra, Nagaland, and Tripura have been declared by the concerned Returning Officers, the Model Code of Conduct has ceased to be in operation with immediate effect except in 144-Falta Assembly Constituency in the State of West Bengal, where fresh poll has been ordered by the Commission.

3. This may be brought to the notice of all concerned.
