How to Apply

Eligible and interested Indian National candidates are required to appear in-person at CSIR- Indian Institute of Petroleum, Mohkampur, Haridwar Road, Dehradun, Uttarakhand for walk-in-interview on the above mentioned stipulated date and time along with duly filled-in application form given with this advertisement, supported by one set of self attested copies of certificates regarding (i) Educational Qualification, (ii) Age, (iii) Category (in case of SC/ST/OBC/PWD candidates), (iv) One latest passport size photograph, (v) Experience certificate, if any; and (vi) detailed biodata etc. Original certificates are required for verification, which would be returned immediately on the same day after verification.

The request for online interview from candidates from far flung areas received through email on recruitment.iip@csir.res.in shall be entertained only in case of poor response for the respective position(s) and also subject to the permission by the Selection Committee/Competent Authority. If large number of candidates appears in person for any position, the requests of online interview shall not be entertained for that position. The request for online interview shall be accepted or rejected on case-to-case basis on the day of walk-in-interview subject to the response of the candidates appearing in person for the walk-in-interview. General Terms & Conditions

- Engagement will be initially for a period of six months/one year or project duration whichever is less depending upon the project requirement, which may be extended or curtailed depending on the duration of the project/desired level performance or conduct of the incumbent, as the case may be.
- Tenure of engagement of the Project Staff shall be co-terminus with the project. However, under no circumstances the tenure would be allowed to exceed six years duration taken into consideration engagement in all CSIR Labs. The performance of the Project Staff would be reviewed periodically so that any one not found up to the mark, could be terminated without assigning any reason.

- In case the selected candidate has resided abroad for more than one year during the preceding five years, then his Character and Antecedent Verification shall be conducted through the Intelligence Bureau (IB) before issuing offer of engagement.
- Each Selected candidate shall sign an undertaking/Non disclosure Agreement for maintaining confidentiality of project findings and/or any associated intellectual property information.
- No project personnel shall be allowed to shift from one project to another until and unless he/she is selected afresh.
- Project personnel engaged as per these guidelines shall be eligible to medical facilities at CSIR Dispensaries of the institute, to the extent of consultation and/or available medicines at the dispensary and transport facilities, if any, as per the terms and conditions with which it is provided by the Institute.
