इसके अतिरिक्त, इसका आशय यूल टी की खरीद हेतु किसी प्रकार की वित्तीय सहमति/वित्तीय स्वीकृति अथवा एकल नामांकन/सिंगल टेंडर आधार पर क्रय की स्वीकृति के रूप में नहीं समझा जाएगा। किसी भी वास्तविक खरीद की स्थिति में प्रचलित जीएफआर, खरीद नियमों, दर-औचित्य, प्रतिस्पर्धात्मकता, बजट उपलब्धता तथा सक्षम प्राधिकारी की स्वीकृति सहित निर्धारित सामान्य प्रक्रिया का पालन किया जाना अनिवार्य होगा। केवल उक्त पत्र के आधार पर उच्च दरों पर अथवा सामान्य खरीद प्रक्रिया से हटकर कोई क्रय नहीं किया जाएगा।
