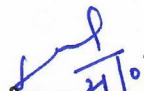

19.	This Office has received applications from Sh. S.P. Prabhakar, SPO, IMTech and Sh. Jai Prakash, COFA, HRDC requesting for MACPs in the light of CSIR OM No. 5-1(234)/2014-PD dated 03.07.2026 regarding withdrawal of the NFS granted to SOs and PSs.	As on date the CSIR Order No. 5-1(234)/2014-PD dated 03.07.2026, 17.07.2026 and 31.07.2026 have been challenged in the Hon'ble CAT Delhi Bench (OA No. 2836/2026) & Lucknow Bench (O.A./428/2026 (LUCKNOW)), and the operation of CSIR orders referred above have been stayed. In view of the pendency of the matter before the Hon'ble CAT and the interim stay on the operation of the aforesaid orders, it has been decided by the Competent Authority to keep the requests for grant of MACPs on account of withdrawal of NFS in abeyance until further orders.
