NBRI, Lucknow is renowned for its Botanic Gardens and Herbarium. It has extensive research farms at Banthra and Mahoba in U.P. The Institute is engaged in R&D on plant sciences spanning across traditional and economic botany, conservation and environmental biology, cytogenetics, floriculture, molecular biology, genetic engineering, plant breeding, taxonomy and bio-informatics. In recent years, it has excelled in developing novel herbal products. NBRI's annual budget is about of Rs. 20 crores and it has a S&T staff strength of around 350 of which nearly 100 are qualified scientists.

Responsibilities: The Director as the Chief Executive of the Institute would be responsible inter-alia for developing and managing a perspective plan for the Institute; providing scientific leadership to the diverse R&D groups; management of day to day operations including human resource management; promoting inter-laboratory and inter-agency R&D programmes and missions; negotiating and acquiring R&D grants/contracts; and building linkages with stakeholders and users.

Qualifications: Ph.D.(Science) with 16 years of experience relevant to the activities of the Institute.

Candidate: Should be creative, innovative and a well established scientist/technologist having a demonstrated ability to create an environment conducive to nurturing of high class research and development. Age around 50 years.

Appointment: will be on contract for a period of 6 years or upto superannuation at the age of 60 years whichever is earlier in the pay scale of Rs. 18400-500-22400/ Rs. 22400-525-24500 (depending on individual's own merit) plus allowances as admissible.
