The CSIR-Traditional Knowledge Digital Library (CSIR-TKDL) Unit is engaged in the protection and preservation of India's vast traditional knowledge present in ancient texts by converting the information into modern languages. It aims to prevent the misappropriation of Indian Systems of Medicine through patenting at the international level. CSIR-TKDL Unit is a unit under the Council of Scientific and Industrial Research (CSIR), an autonomous body with the Department of Scientific and Industrial Research (Ministry of Science and Technology). Applications are invited from qualified candidates (Indian nationals and non-Indians as per GoI provisions in place) who meet the necessary educational and work requirements to work on project titled "Digitization of Indian Systems of Medicine – Siddha and Sowa Rigpa" (MLP0005). The engagement is purely on temporary and contract basis. The engagement shall be initially up to 31 March 2021 and maximum until 31 March 2025, i.e., co-terminus with the project. The extension of tenure of any project staff beyond 31 March 2021 will be subject to review by a Review Committee at the end of each year or earlier, as deemed necessary. ### Monthly emoluments:

#### For Project Associate – I

#### For Project Assistant

Rs. 20,000/-+HRA with increment of 15% for 3 years of experience

**Age Limit:** 35 years for Project Associate-I and 50 years for Project Assistant as on date of written test/interview. The above age limits are relaxable for candidates of statutory groups as per CSIR/Govt. of India instructions on the subject.

#### Job Requirement:

Preference will be given to those with proficiency in computers and commonly used software with the ability to work as a part of a team.

#### General Conditions:

(a) The engagement which is on contract basis in respect of all above positions will confer no rights on the candidates, whatsoever, implicitly and / or explicitly for their continuation beyond tenure/absorption / regularization in CSIR. Contract may be terminated at any time at a notice of one month from either side or one month stipend in lieu thereof.

(b) Project staff would be governed by the Guidelines relating to engagement of project staff in CSIR Projects including NMITLI projects, OLP/MLP, Contract R&D and non-CSIR funded Projects issued by CSIR vide OM No. 4/CMG/2020-TMDII dated 13 August 2020.

(c) The project staff may be required to travel as per need.

(d) Reservation (SC/ST/OBC/PwD) will be applicable as per CSIR/Govt. of India instructions on the subject.

(e) Head, CSIR-TKDL Unit reserves the right to increase/ decrease the number of positions and also cancel the recruitment process for the positions mentioned above at any stage of the recruitment process. The decision of the Head, CSIR-TKDL Unit will be final and binding.

**Note:**

(a) Candidates applying for TKC501, TKC502 & TKC503 should present themselves at CSIR-Central Leather Research Institute (CSIR-CLRI), Sardar Patel Road, Adyar, Chennai – 600 020; while those applying for TKL501 and TKL502 should present themselves at National Research Institute for Sowa Rigpa, Skalzangling, Near Head Post Office, Leh 194101 Ladakh for a Written test at the above mentioned dates against each post, the timing of which will notified on the CSIR website or through email. The interview of shortlisted candidates will take place online, the details of which will be made available on CSIR website. The results of the written test will be declared the same day or next day. The candidates are requested to visit the CSIR website or their email frequently to know the information and status.

(b) The candidates must bring with them original certificates/ testimonials at the time of test along with two copies of self-attested photographs and a set of self-attested copies of certificates/ testimonials in support of age, qualification, marks obtained, experience, if any, etc. The candidates must also bring a copy of their bio-data neatly typed on A4 paper.

(c) The candidates belonging to reserved categories must bring their original certificate of categories to which they belong issued by the competent authority (along with self attested copies of the same).

(d) No TA/DA will be paid for attending the Test/ Interview.

(e) If currently employed, then the candidate will have to furnish no-objection certificate from the current employer at the time of joining.

(f) Candidature will be purely provisional subject to fulfilling the eligibility criteria.

(g) Canvassing in any form will render the candidate disqualified.

**Other Instructions to Candidates:**
