It would help integrate similar effort being made by various Indian S&T departments / agencies to bring together the Scientific Diaspora using a virtual platform to address the Indian societal challenges / problems and promote collaboration between resident and non-resident Indian scientists.

Draft Terms of Reference for the Working Group*

- Integrating PRABHASS with VAIBHAV Summit Outputs
- Framing Implementation policies for the outcomes/outputs from the VAIBHAV Summit
- Facilitating collaborations on value proposals and serve as Inter-Ministerial Committee for enabling mechanisms for collaboration and evaluation of proposals for collaborative R&D projects, workshops/Webinar, trainings, fellowship etc. Facilitating execution of International Cooperation related to different activities and collaboration requests.
- Framing Policy Guidelines for enhancing the engagement with Diaspora and way ahead for this initiative to address the societal challenges through S&T interventions
- Facilitating Implementation of Government effort including realization of Make-In-India and "Aatm Nirbhar Bharat Schemes
- Conducting periodic reviews/follow-ups of the activities and progress of this initiative
- Suggesting establishment and launch of collaborative programmes / schemes and suggesting potential
 international collaboration possibilities (such as for a) Facilitating upgradations and standardizations of
 Indian Technologies as per the Global Standards; b) Showcasing the Indian Technologies developed
 under different initiatives by Indian departments/agencies to the world and support the technology transfer
 effort; c) Facilitating Inputs to technological gaps
- Facilitating Technology Transfer agreements and connecting the Indian S&T departments/agencies with the global diaspora experts and industries/R&D institutes for promoting and transferring Indian technologies.
- Bringing on board relevant Central and State ministries/bodies for effective and smooth implementation of these efforts
- Facilitating implementation of solutions through Central & State Ministries/bodies for Societal Benefits
- Connecting and developing Entrepreneurs
- Identification of nodal agency for portal management, implementation and coordination with the Working Group.
